PROVIDING FOR THE FOLLOWING: FINDINGS OF FACT; ENACTMENT; REPEALER; SEVERABILITY; CODIFICATION; EFFECTIVE DATE; AND PROPER NOTICE AND HEARING.

BUSINESS DISTRICT (B-4), AND AS A PERMITTED USE IN THE LIGHT MANUFACTURING DISTRICT (M-1); TO ADD RESTAURANTS (NO DRIVE-THRU) AS A PERMITTED USE IN THE PROFESSIONAL BUSINESS DISTRICT (B-1); TO ADD BEER AND WINE RETAIL SALES BY SPECIAL USE PERMIT IN THE PROFESSIONAL BUSINESS DISTRICT (B-1) AND THE COMMUNITY RETAIL BUSINESS DISTRICT (B-2); TO ADD RETAIL, GENERAL AS A PERMITTED USE IN THE PROFESSIONAL BUSINESS DISTRICT (B-1); TO ADD TAVERN AS A SPECIAL USE PERMIT IN THE PROFESSIONAL BUSINESS DISTRICT (B-1), COMMUNITY RETAIL BUSINESS DISTRICT (B-2), AND SECONDARY & HIGHWAY BUSINESS DISTRICT (B-3); REMOVE TOWNHOMES FROM BEING AN ALLOWED USE IN THE PROFESSIONAL BUSINESS DISTRICT (B-1); AND TO ADD MIXED USE DEVELOPMENT AS A SPECIAL USE PERMIT IN THE COMMUNITY RETAIL BUSINESS DISTRICT (B-2); AND PROVIDING FOR THE FOLLOWING: FINDINGS OF FACT; REPEALER; SEVERABILITY; EFFECTIVE DATE; AND PROPER NOTICE AND HEARING.

## MAIN STREET SPUR OVERLAY DISTRICT ORDINANCE NO. Z 19-08 #3

AN ORDINANCE OF THE CITY OF NOLANVILLE, TEXAS AMENDING CHAPTER 14, ZONING, ADDING REQUIREMENTS FOR DIVISION 15, SECTION 415, TO CREATE THE MAIN STREET OVERLAY DISTRICT.
