6. ACTION ITEMS

A. Discuss Boys & Girls Club program transition for back to school, change of hours, events and attendance.

Dusti Swanson of the Boys & Girls Club Program explained the program transition for back to school. Discussion commenced.

B. Discussion and possible approval of end of year budget amendment for Capital Purchases, Ordinance F 19-08:

Motion was made by Councilmember David Williams to approve Budget Amendment for Capital Purchases Ordinance No F 19-08; motion was second by Mayor Pro-tem Joan Hinshaw. All voted in favor. Motion was carried 5-0.

- C. Discussion and possibly authorize purchases for Police Capital Outlay:
 - 1.) WatchGuard
 - (a.) Video Library, \$6,150
 - **(b.)WatchGuard in car video and body camera system, \$6,425**Justification: Storage requirements for body and vehicle camera data. Hardware devices for the police vehicle (Crown Vic).
 - 2.) ExtraCo Technology, \$21,819

 Justification: Life cycle replacement for existing 2012 server and additional server for camera storing capacity.
 - 3.) Cap Fleet Upfitters,
 - (a.) Installation for Crown Vic \$ 8,421
 - **(b.)** Installation for Wi-Fi mobile access points in vehicle, \$1,380

 Justification: Outfit previously purchased police vehicle with required equipment to include radar and access points for three other vehicles.

Motion was made by Councilmember James Bilberry to approve purchases for Police Capital Outlay (Items C1, C2 & C3); motion was second by Councilmember George French III. All voted in favor. Motion was carried 5-0.

- D. Discussion and possible approval of Administration Capital Outlay
 - 1.) Tyler Technology Software Upgrades Call Center & Payroll Features, \$12,070
 - 2.) KSA Facility Assessments \$8750

Motion was made by Councilmember David Williams to purchases for Administration Capital Outlay; motion was second by Councilmember James Bilberry. All voted in favor. Motion was carried 5-0.

E. Discuss Park Grant progress to include status of Multi use field, Trail Bid, Dog Park and Community Garden to include budgeting strategy.

F. Discussion and possible approval of Charter Amendment, Ordinance D 19-08:

AN ORDINANCE OF THE CITY OF NOLANVILLE, TEXAS, TO APPROVE NON-SUBSTANTIVE AND OTHER REVISIONS TO THE HOME RULE CHARTER ADOPTED ON NOVEMBER 11, 2010 AND AMENDED PURSUANT TO ORDINANCE 2014-11-04 #007, ADOPTED ON AUGUST 11, 2014, AS APPROVED AT THE ELECTION OF NOVEMBER 4, 2014; AND OTHER PROVISIONS INCIDENT OR RELATING TO THE SAID REVISIONS; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

Motion was made by Councilmember James Bilberry to approve Charter Amendment Ordinance D 19-08; motion was second by Councilmember George French III. All voted in favor. Motion was carried 5-0.

G. Discussion on Main Street Parking.

Discussion commenced on Main Street Parking. City Council would like to entertain an ordinance that would also cover Main Street Parking.
