A. Discussion and possibly take action on a Letter of Agreement between the City of Nolanville, Texas and Grant Development Services Inc to provide professional services required to develop and submit a complete grant application to the Texas Commission on Environmental Quality's 319 Grant Program to prevent or reduce nonpoint Source water pollution, and, if the application receives funding, to utilize the services of Grant Development Services Inc to administer project implementation. Project Location is withing City limits for channel improvement along the East & West Tributary leading to Nolan Creek (behind City Hall and along 10th Street to the HWY 190 Access Road).

CODE 23.243 TO INCREASE DISTRIBUTION RATES WITHIN THE CITY SHOULD BE DENIED; REQUIRING NOTICE OF THIS RESOLUTION TO THE COMPANY; FINDING THAT THE MEETING AT WHICH THIS RESOLUTION IS PASSED WAS NOTICED AND IS OPEN TO THE PUBLIC AS REQUIRED BY LAW.
