D20-05 #1 AMENDING CHAPTER 7 "MUNICIPAL COURT" ESTABLISHING THE MUNICIPAL COURT IN NOLANVILLE AS A MUNICIPAL COURT OF RECORD BY EXTENDING THE COURT'S JURISDICTION TO INCLUDE CIVIL JURISDICTION IN CERTAIN CIRCUMSTANCES; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE OF ALL ORDINANCES; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A SAVINGS CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

AN ORDINANCE OF THE CITY OF NOLANVILLE, TEXAS, AMENDING ORDINANCE C17-06, REGULATING SIGNS AND BILLBOARDS, ARTICLE 3.07, SIGNS, DIVISION 1, SUBSECTIONS 3.07.007(4) AND (5) OF THE CODE OF ORDINANCES "SIGN REQUIREMENTS BY ZONING DISTRICT" BY AMENDING THE DIMENSIONAL SIGN REQUIREMENTS FOR WALL, CANOPY, AND PROJECTING SIGNS IN SECONDARY AND HIGHWAY BUSINESS DISTRICT (B-3), GENERAL BUSINESS DISTRICT (B-4), LIGHT MANUFACTURING DISTRICT (M-1) AND HEAVY MANUFACTURING DISTRICT (M-2), AND PROHIBITING POLE SIGNS IN PROFESSIONAL BUSINESS DISTRICT (B-1) AND COMMUNITY RETAIL BUSINESS DISTRICT (B-2); AND PROVIDING FOR SEVERABILITY, REPEALER, AND AN EFFECTIVE DATE.

Motion was second by Mayor Pro-tem James Bilberry. All voted in favor. Motion was carried 5-0.

AN ORDINANCE OF THE CITY OF NOLANVILLE, TEXAS, AMENDING CHAPTER 4, BUSINESS REGULATIONS, ESTABLISHING REGULATIONS FOR BUSINESSES NOT LICENSED OR PERMITTED BY THE TEXAS ALCOHOLIC BEVERAGES COMMISSION TO SELL OR SERVE ALCOHOLIC BEVERAGES WHICH ALLOW PATRONS TO BRING ALCOHOLIC BEVERAGES ONTO THEIR PREMISES ("BYOB BUSINESSES"); AND

PROVIDING FOR THE FOLLOWING: FINDINGS OF FACT; ENACTMENT; REPEALER; SEVERABILITY; PENALTY CLAUSE; PUBLICATION; CODIFICATION; EFFECTIVE DATE; AND PROPER NOTICE AND MEETING.
