4. ACTION ITEMS

- A. Discuss and possibly approve extending the waiving of permit fees for the following:
 - 1) Habitat for Humanity for new construction and home repair assistance.
 - 2) Nolanville Faith Outreach for future clinic.

Both entities were previously approved for one (1) year at RCM 02.04.2021.

1) Motion was made by Mayor Pro-tem Patrick Ramsdell to approve waiving of permit fees for Habitat for Humanity for new construction and home repair assistance for one (1) year; motion second by Councilmember James Bilberry. Four (4) voted in favor and one (1) abstained. Motion carried 4-1.

- 2) Motion was made by Councilmember Butch Reis to approve waiving of permit fees for Nolanville Faith Outreach for future clinic for one (1) year; motion was second by Councilmember David Williams II. All voted in favor. Motion carried 5-0.
- B. Discuss and possibly approve Economic Development Members:

Motion was made by Councilmember David Williams II to appoint Marcy Ng and Alan Wevodau to the Economic Development Board; motion was second by Councilmember Butch Reis. All voted in favor. Motion carried 5-0.

Motion was made by Mayor Pro-tem Patrick Ramsdell to appoint Rod Woods to Seat 5 of the Planning & Zoning Commission and to Seat 3 of the Zoning Board of Adjustments; motion was second by Councilmember David Williams II. Four (4) voted in favor and one (1) against. Motion carried 4-1.

Motion was made by Mayor Pro-tem Patrick Ramsdell to appoint Angela Austin as alternate for both Planning & Zoning Commission & Zoning Board of Adjustments; motion second by Councilmember James Bilberry. All voted in favor. Motion carried 5-0.

D. Discuss and possibly approve Terms and Roles for Planning & Zoning and Board of Adjustments.

A motion was attempted to be initiated by Councilmember James Bilberry and second by Councilmember Butch Reis but withdrawn before completion.

Motion was made by Councilmember David Williams to re-appoint Jerry Wittkop and appoint Rod Woods as primary member of the Planning & Zoning Commission to end November 2024; motion was second my Mayor Pro-tem Patrick Ramsdell. All voted in favor. Motion carried 5-0.

Motion was made by Councilmember David William to appoint Tinara Grisham, Dean Huard, and Rod Woods as primary members to the Zoning Board of Adjustments and re-appoint Jerry Wittkop as alternate for ZBA for all terms to run through November 2021; motion second by Councilmember James Bilberry. Motion carried 5-0.

E. Discuss and possibly approve KPA Proposal in the amount of \$87,400 for professional engineering services related to the Community Development Block Grant for the Plaza Wastewater Line Rehabilitation.

All voted in favor. Motion carried 5-0.
