They stated the fire hydrant water pressure was the cause of not being able to save their home. As a result the Austin's feel the City failed them.

Greg Pirata and Wife also stated the fire hydrant pressure was the cause of the loss for 257 West Fir. Mr. Perata's wife suffered 3rd degree burns, smoke inhalation and experienced a hospital stay on life support.
