#### 4. CONSENT AGENDA

A. Consider approval of Minutes for Regular Call Meeting of (September 23) September 16, 2021.

Motion was made by Mayor Pro-tem David Williams to approve the meeting Minutes of September 23, 2021. During the motion, the date of the meeting minutes were called into question because it was incorrect. Motion was rescinded.

Motion was made by Mayor Pro-tem David Williams to approve the Minutes for Regular Call Meeting of September 16, 2021; motion was second by Councilmember Butch Reis. All voted in favor. Motion carried 5-0.

### 5. ACTION ITEMS

A. Presentation by Dr. John Craft, KISD, followed by questions from the Council.

Dr. John Craft provided a presentation on KISD and its rezoning; this was followed by questions and discussion on the matter of rezoning.

B. Discuss power outages with ONCOR Customer Operations, Karl Green, followed by questions from the Council.

C. Discuss and possibly approve **Resolution NEDC 09-21** – Business Incentives for Subway in the amount of \$46,021.00 over a three-year period.

Motion was made by Councilmember James Bilberry to approve Resolution NEDC 09-21 – Business Incentives for Subway in the amount of \$46,021.00 over a three-year period; motion was second by Mayor Pro-tem David C. Williams II. All voted in favor. Motion carried 5-0.

D. Discuss and possibly approve underpass lighting from RK Bass for \$170,744 from Capital Outlay; Nolanville Economic Development Corporation is contributing a 50% match.

Motion was made by Mayor Pro-tem David C. Williams II to <u>postpone</u> the matter to possibly approve the underpass lighting from RK Bass for \$170,744 from Capital Outlay for a later date and at the City Manager discretion based on funds

availability; motion was second by Councilmember Butch Reis. Four (4) voted in favor and one (1) against. Motion passed 4-1.

E. Discuss and possibly approve EDC Pavilion at 204 North Main Street for \$13,136; \$6836.63 to Metal Mart for materials and \$6300 to David Caldwell for labor and concrete.

Motion was made by Mayor Pro-tem David C. Williams to approve the EDC Pavilion at 204 North Main Street for \$14,000 for materials, concrete and labor; motion second by Councilmember Patrick Ramsdell. All voted in favor. Motion carried 5-0.
