E. Discuss and possibly approve: ORDINANCE NO. D 21-03

AN ORDINANCE AMENDING CHAPTER 12, TRAFFIC AND VEHICLES, ARTICLE, 12.03, BY ADDING SECTION 12.03.003 TO THE CITY OF NOLANVILLE, TEXAS, CODE OF ORDINANCES; DESIGNATING NORTH SECOND STREET AS A ONE-WAY STREET IN THE CITY OF NOLANVILLE, TEXAS; PROVIDING FOR INSTALLATION OF SIGNAGE; PROVIDING ENACTMENT AND PENALTY CLAUSES; PROVIDING PROPER NOTICE, SEVERABILITY, AND EFFECTIVE DATE CLAUSES; AND PROVIDING FOR RELATED MATTERS.

Motion was made by Councilmember Joan Hinshaw to approve Ordinance No. D 21-03, and emphasizing North 2nd Street to be one-way northbound; motion was second by Councilmember Butch Reis. All voted in favor. Motion carried 5-0.

Motion was made by Councilmember James Bilberry to suspend agenda and move Item F after Item H on the agenda; motion second by Councilmember Butch Reis. All voted in favor. Motion carried 5-0.

F. Discuss and possibly approve CONTRACT AGREEMENT between Kaunica Byrd of KB Fitness and the Economic Development Corporation. (Tabled on March 18, 2021, Regular Council Meeting).

The Item F was heard by City Council after Item H.

Motion was made by Councilmember James Bilberry to approve the CONTRACT AGREEMENT between Kaunica Byrd of KB Fitness and the Economic Development

Corporation; motion second by Councilmember Butch Reis. All voted in favor. Motion carried 5-0.

G. Discuss and possibly approve SERVICES AGREEMENT between MEv Sports, LLC and the City of Nolanville for recreational sports programming.

Motion was made by Councilmember James Bilberry to approve the SERVICES AGREEMENT between MEv Sports, LLC and the City of Nolanville for recreational sports programming including the Nolanville Cowboys having the right to continue their program and the word, "exclusive" being struck from the contract, motion second by Councilmember Butch Reis. Two (2) voted in favor and three (3) voted against. Motion not carried 2-3.

This motion did not pass and was reconsidered.

Motion was made Councilmember James Bilberry to table this Services Agreement between Mev Sports, LLC to allow for changes to the contract and all liability issue concerns; motion second by Councilmember Butch Reis. All voted in favor. Motion carried 5-0.

H. Discussion with possible action on establishing a Neighborhood Empowerment Zone pursuant to Chapter 378 of the Local Government Code to promote the creation of affordable housing and select incentives for the zone, including tax abatement agreements and waiver of permit fees.

Motion was made by Councilmember James Bilberry to approve the City Manager establish a Neighborhood Empowerment Zone pursuant to Chapter 378 of the Local Government Code to promote the creation of affordable housing and select incentives for the zone, including tax abatement agreements and waiver of permit fees; motion second by Councilmember Patrick Ramsdell. All voted in favor. Motion carried.
