

# REGULAR MEETING MINUTES THURSDAY, April 15, 2021 AT 6:00 PM by Audio Teleconference

## 4. CONSENT AGENDA

**A.** Discuss and possibly approve purchase of evidence locker from Grainger for \$6500 utilizing grant funding.

Motion was made by Councilmember James Bilberry to approve purchase of evidence locker from Grainger for \$6500 utilizing grant funding; motion second by Councilmember Patrick Ramsdell. All voted in favor. Motion carried 4-0.

**B.** Discuss and possibly approve purchase of 2011 Ford Crown Victoria Police Interceptor from Bill Bess for \$10,500 from Police Capital Outlay.

Kara Escajeda, City Manager explained the Ford Crown Victoria is a 2008 model not a 2011 and correct name for Bill Bess to be Bill Best. She asked that City Council note the correction.

Motion was made by Councilmember Patrick Ramsdell to approve the purchase of 2008 Ford Crown Victoria Police Interceptor from Bill Best for \$10, 500 from Police Capital Outlay; motion second by Councilmember Butch Reis. All voted in favor. Motion carried 4-0.

**C.** Discuss and possibly approve purchase of 2017 Ford Explorer Police Interceptor from John Wright and Associates for \$25,000 from Police Capital Outlay.

Motion was made by Councilmember James Bilberry to approve purchase of 2017 Ford Explorer Police Interceptor from John Wright and Associates for \$25,000; motion second by Councilmember Butch Reis. All voted in favor. Motion carried 4-0.

**D.** Discuss and possibly approve purchase LPR readers and Investigative Platform Subscription for \$10,580 from Watchguard Video utilizing grant funding.

Motion was made by Councilmember Patrick Ramsdell to approve purchase of LPR readers and Investigative Platform Subscription for \$10,580 from Watchguard Video utilizing grant funding; motion second by Councilmember Butch Reis. All voted in favor. Motion carried 4-0.

Motion was made by Councilmember Butch Reis to approve Ordinance No. F 04-21 #5; motion second by Councilmember Patrick Ramsdell. All voted in favor. Motion carried 4-0.

F. Discuss and possibly approve SERVICES AGREEMENT between MEv Sports, LLC and the City of Nolanville for recreational sports programming. (Tabled April 1, 2021 during Regular Council Meeting).

Motion was made by Councilmember Patrick Ramsdell to approve SERVICES AGREEMENT between MEv Sports, LLC and the City of Nolanville for recreational sports programming and to add that MeV Sports will be providing 4 scholarships with the clinic; motion second by Councilmember Butch Reis. Three (3) voted in favor and one (1) against. Motion carried 3-1.

**G.** Discuss and possibly set a workshop date for Neighborhood Empowerment Zones and Tax Reinvestment Zones.

City Council agreed to set the workshop date to discuss the Neighborhood Empowerment Zones and Tax Reinvestment Zones for Thursday, April 22, 2021.
