B. Discuss and possibly approve RESOLUTION NO. M 21-08

A RESOLUTION AUTHORIZING THE CREATION OF THE CENTRAL TEXAS REGIONAL
9-1-1 EMERGENCY COMMUNICATIONS DISTRICT

Motion was made by Mayor Pro-tem David Williams II to approve Resolution No. M 21-08; motion was second by Councilmember Butch Reis. All voted in favor. Motion was carried 5-0.

C. Discuss and possibly approve Ordinance No. E 21-08 #1:

AN ORDINANCE CALLING AND ORDERING A GENERAL ELECTION FOR THREE (3) COUNCILMEMBERS FOR TWO (2) YEAR TERMS: PRESCRIBING THE QUALIFICATIONS FOR CANDIDATES; PROVIDING FOR THE FILING OF WRITTEN APPLICATION TO HAVE THEIR NAMES PRINTED ON THE OFFICIAL BALLOT; FIXING THE TIME WITHIN WHICH SUCH APPLICATION MAY BE FILED; SPECIFYING THAT THE PROVISIONS OF THE GENERAL ELECTION LAWS SHALL CONTROL ALL QUESTIONS PERTAINING TO SUCH ELECTION; PRESCRIBING THE CONTENTS OF THE OFFICIAL BALLOT; ADOPTING A BILINGUAL ELECTION ORDER, AND PROVIDING FOR POSTING AND PUBLICATION OF NOTICE OF SAID ELECTION:

Motion was made by Councilmember James Bilberry to approve Ordinance No. E 21-08 #1; motion was second by Councilmember Patrick Ramsdell. All voted in favor. Motion was carried 5-0.

D. Discuss and possibly approve Ordinance No. E. 21-08 #2:

AN ORDINANCE CALLING AND ORDERING A SPECIAL ELECTION TO BE HELD IN THE CITY OF NOLANVILLE, TEXAS, IN CONJUNCTION WITH THE TEXAS GENERAL ELECTION ON NOVEMBER 2, 2021 TO SUBMIT A PROPOSITION ON

THE REAUTHORIZATION OF THE LOCAL SALES AND USE TAX AT THE RATE OF ONE-FORTH (1/4) OF ONE PERCENT (1%) TO CONTINUE PROVIDING REVENUE FOR THE MAINTENANCE AND REPAIR OF MUNICIPAL STREETS; MAKING PROVISION FOR THE CONDUCT OF SUCH ELECTION; RESOLVING OTHER MATTERS INCIDENT AND RELATED TO SUCH ELECTIONS; FINDING PROPER NOTICE AND MEETING, AND PROVIDING FOR AN EFFECTIVE DATE.

Motion was made by Councilmember Butch Reis to approve Ordinance No. E 21-08 #2; motion was second by Mayor Pro-tem David Williams II. All voted in favor. Motion was carried 5-0.

E. Discuss and possibly approve TMRS Ordinance No. F 21-08 #1:

AN ORDINANCE PROVIDING FOR A CHANGE IN THE MUNICIPAL CONTRIBUTIONS TO THE CURRENT SERVICE ANNUITY RESERVE AT RETIREMENT OF THE EMPLOYEES OF THE CITY OF NOLANVILLE, TEXAS.

Motion was made by Councilmember James Bilberry to approve TMRS Ordinance No. F 21-08 #1; motion was second by Mayor Pro-tem David Williams II. All voted in favor. Motion carried 5-0.

F. Discuss and possibly approve TMRS Ordinance No. F 21-08 #2:

AN ORDINANCE AUTHORIZING AND ALLOWING, UNDER THE ACT GOVERNING THE TEXAS MUNICIPAL RETIREMENT SYSTEM, RESTRICTED PRIOR SERVICE CREDIT TO EMPLOYEES WHO ARE MEMBERS OF THE SYSTEM FOR SERVICE PREVIOUSLY PERFORMED FOR VARIOUS OTHER PUBLIC ENTITIES FOR WHICH THEY HAVE NOT RECEIVED CREDITED SERVICE; AND ESTABLISHING AN EFFECTIVE DATE FOR THE ORDINANCE.

Motion was made by Mayor Pro-tem David Williams II to approve TMRS Ordinance No. F 21-08 #2; motion was second by Councilmember Butch Reis. All voted in favor. Motion carried 5-0.
