

REGULAR MEETING MINUTES THURSDAY, September 2, 2021 AT 6:00 PM

THE CITY COUNCIL WILL CONVENE IN A REGULAR MEETING, BY VIDEO TELEPHONE CONFERENCE AND IN PERSON, AT CITY HALL, 101 NORTH 5th STREET, NOLANVILLE, TEXAS 76559

1. CALL TO ORDER, INVOCATION AND PLEDGES TO FLAGS

Mayor Andy Williams called the meeting to order at 6:00 pm. Mayor Pro-tem David Williams II, Councilmembers Joan Hinshaw (via teleconference), Patrick Ramsdell and James Bilberry were all present for the meeting. Councilmember Butch Reis was absent.

Councilmember James Bilberry performed the Invocation and Mayor Andy Williams led the Pledges to the Flags.

3. CITIZENS/VISITORS' FORUM

Any person with business before the Council not scheduled on the agenda may speak to the Council. No formal action can be taken on these items at this meeting.

Nolanville resident Chris Norman asked the City Council why they approved such a strict COVID-19 disaster declaration giving the Mayor so much power without consideration of the citizens and their families.

Mayor Andy Williams explained that the wording of Nolanville's declaration needed to mirror the words of Bell County's recently reissued disaster declaration in order for the City to continue to seek federal and state funding for pandemic-related eligible expenses.

Mayor Andy Williams thanked Mr. Norman for attending the City Council meeting and presented him with the Mayor's Coin, the Community that Cares Award of Excellence Medallion. City Council also thanked Mr. Norman.

AN ORDINANCE OF THE CITY OF NOLANVILLE, TEXAS, SETTING A PROPERTY (AD VALOREM) TAX RATE AND APPROVING THE FISCAL YEAR 2021-2022 AD VALOREM TAX RATE AND LEVY OF (\$0.4674) PER ONE HUNDRED DOLLARS (\$100) OF ASSESSED VALUATION OF ALL TAXABLE PROPERTY WITHIN THE CORPORATE LIMITS OF THE CITY; AND PROVIDING FOR SEVERABILITY AND DECLARING AN EFFECTIVE DATE.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.
