Max Muston 101 Button Bush – disapproved of rezoning- concerns over traffic in and out of area and vehicle safety and drainage concerns as well.

John Campbell 215 Black Walnut Ct - disapproved of rezoning as is – only 2 entrance/exit points, access in and out of area limited and would cause traffic issues. Also recommended overpass for railroad tracks and to visit what other cities are doing with trains blocking traffic.

Mike Atkinson 208 Slippery Elm – disapproved of rezoning as is – concerns with property value being lowered with designated duplexes.

John Polis 102 Slippery Elm – disapproved of rezoning as is – concerns over traffic in and out of area and possible drainage issues.

Veleka Berry 102 Slippery Elm – disapproved of rezoning as is – concerned with having duplexes in the development and providing affordable housing and traffic in and out of area.

Lorenzo Garcia 105 Black Walnut Ct- disapproved of rezoning – also expressed concerns over traffic and how that would affect EMS services who need to gain access.

Edward Taylor 107 Black Walnut Ct – disapproved of rezoning – concerned with having HOA enforcement.
