**SECTION 3.06.007 PERMITS AND CODE COMPLIANCE (A)**

- (A) A MOBILE HOME WILL NOT BE PERMITTED IN THE CITY LIMITS UPON PRIVATE PROPERTY THAT IS NOT ALREADY ZONED FOR MOBILE HOMES. ANY PERSON MOVING OR CAUSING TO BE MOVED A MOBILE HOME INTO THE CITY WILL OBTAIN A PERMIT PRIOR TO SUCH MOVING. IN THE APPLICATION FOR A PERMIT, SHE/HE WILL STATE THE NAME AND [OF THE] OWNER, THE LOCATION TO BE USED, THE EXISTING UTILITIES AND THE UTILITIES TO BE INSTALLED. PERMITS MUST BE OBTAINED EACH TIME A MOBILE HOME IS MOVED TO A NEW LOCATION.**

**THE APPLICANT IS REQUESTING A VARIANCE TO ALLOW THE PLACEMENT OF A MOBILE HOME ON PROPERTY ZONED R-3 (SINGLE-FAMILY RESIDENTIAL), WHICH DOES NOT TYPICALLY PERMIT MOBILE HOMES, IN ACCORDANCE WITH SECTION 3.06.007(A) OF THE CITY OF NOLANVILLE CODE OF ORDINANCES.**
