



## Notice of Interest for Service on the City of Nolanville Boards and Commissions

**Background:** Twice a year, the City Council considers appointment for the City's various Boards and Committees. Upcoming openings are published in the local media with further information available through the City Secretary.

**Criteria:** All residents of the City of Nolanville are encouraged to serve on the various Boards and Committees of the City.

**Instruction:** you may be eligible for appointment to more than one board or committee; but you may only serve on two City Boards or committee simultaneously. Please review the City Boards/Commissions handbook to determine your eligibility. Please call 254-698-6335 if you require assistance.

You will be required to complete the "Application for Appointment to City of Nolanville Boards and Committees." Please be aware information you submit on these forms may be subject to verification during the application process and is subject to the Texas Public Information Act (Government Code Chapter 552). **Review and Appointment Process:** All applications will be reviewed by the City Secretary for completeness and eligibility. Eligible applications will be forwarded to the City Council.

Two City Council members will interview applicants at a work session. Nominees must appear in person for the interview. If you do not attend one of the interview sessions, you will not be considered for appointment.

If an individual is ill, out of town, or cannot appear in person, a written statement must be submitted to the Office of the City Secretary prior to the date of the interview for review by the interview committee.

The interview committee will submit their nomination for each Board and Committee, in writing, to the City Secretary, in the form of a memorandum with their signatures.

The memorandum of suggested appointment will be placed on the next City Council Agenda for consideration by the entire Council.

## **ATTACHMENT A**

### **Citizen Advisory Committee**

City Council appoints community members to weigh in on certain conditions exist in the community relating to housing, infrastructure, economic development, and quality of life which require analysis and long-term planning to improve. Meetings are scheduled as needed.

### **Planning and Zoning Commission**

The Planning and Zoning Commission is charged with making planning and zoning decisions on behalf of the City of Nolanville. The Planning and Zoning Commissions primary responsibility concerns updating and, implementing the land use section of City of Nolanville's Comprehensive Plan. The commission makes reports for, and recommendations to, the City Council regarding changes to zoning regulations, the city's zoning map or the city's zoning ordinance. The commission also calls public hearings to determine proper zoning for a tract of land or for and area. Meetings are held the second Thursday of every month at 6:00 P.M. at the Nolanville Municipal Building, 101 North 5<sup>th</sup> Street, Nolanville, Texas.

### **Zoning Board of Adjustments**

The Zoning Board of Adjustments works administratively with individual and neighborhood zoning decisions. The Zoning Board of Adjustments have the power to hear appeals from individuals contesting the decision of the city's zoning enforcement officer in enforcing the zoning ordinance and city rules and regulations, hear and decide special exceptions/conditional use permits, and grant variances from the provisions of the zoning ordinance when unusual conditions create an unnecessary hardship. Meetings are scheduled as needed.

### **Economic Development Board**

The Nolanville Economic Development Board creates a partnership of the community. The Nolanville Economic Development board leads the economic development activities for the promotion, marketing, attraction and retention to the City of Nolanville; including the attraction & retention of new and existing commercial, industrial and manufacturing prospects, the marketing of industrial and commercial sites and the identification of target commercial and industrial enterprises. Meetings are held the fourth Thursday of every month at 6:00 PM at the Nolanville Municipal Building, 101 North 5<sup>th</sup> Street, Nolanville, Texas.
