



RESOLUTION NO. E 17-11

CITY OF NOLANVILLE, TEXAS

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NOLANVILLE, TEXAS, CANVASSING THE ELECTION HELD ON NOVEMBER 7, 2017 BY CERTIFYING THE GENERAL ELECTION AND SPECIAL ELECTION RESULTS; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, pursuant to Ordinances No. E 17-08 #1 of the City of Nolanville, Texas adopted on the 18th day of August, 2017 a General Election was duly held on the 7th day of November, 2017, for the consideration of electing three (3) councilmembers for City of Nolanville, Texas;

WHEREAS, pursuant to Ordinances No. E 17-08 #2 of the City of Nolanville, Texas adopted on the 18th day of August, 2017 a Special Election was duly held in conjunction with the General Election on the 7th day of November, 2017, for the consideration of a proposition on the reauthorization of the local sales and use tax at the rate of one-fourth (1/4) of one percent to continue providing revenue for the maintenance and repair of municipal streets for the City of Nolanville, Texas;

WHEREAS, said election was held with the solemnities and formalities necessary to make it a valid election, all notices having been posted in the manner and for the length of time required by law; and

WHEREAS, only duly qualified resident voters of the City of Nolanville, Texas, voted at the General Election and Special Election called and held on November 7, 2017; and

WHEREAS, section 67.003 of the Texas Election Code, as amended, generally provides that, except in an election held on the uniform election date in May, each local canvassing authority shall convene not earlier than the eighth (3rd) day or later than the eleventh (11th) day after each General Election or Special Election date for the purpose of canvassing the election results; and;

WHEREAS, section 67.004(a) of the Texas Election Code, as amended, establishes the quorum level required to canvass election results, that being at least two (2) members of the City Council; and

WHEREAS, a quorum of the City Council met on Thursday, November 20, 2017, and duly canvassed the election returns of the above mentioned election and finds that the tabulation of the results of the election is correct, hereby attached as *Exhibit A*.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NOLANVILLE, TEXAS:

Section 1. The findings set forth above are incorporated into the body of this Resolution as if fully set forth herein.

Section 2. That the City Council officially finds and determines a General Election was duly ordered to be held in the City of Nolanville, Texas on the 7th day of November 2017 for the purpose of electing three (3) Councilmembers for the City of Nolanville, Texas, and that proper notice of said election was duly given; that said election has been made and delivered by Bell County Elections Division; and that the City Council has duly canvassed said returns all in accordance with the Texas Election Code.

Section 2. That the City Council officially finds and determines a Special Election was duly ordered to be held in the City of Nolanville, Texas on the 7th day of November 2017 for the consideration of a proposition on the reauthorization of the local sales and use tax at the rate of one-fourth (1/4) of one percent to continue providing revenue for the maintenance and repair of municipal streets for the City of Nolanville, Texas for the City of Nolanville, Texas, and that proper notice of said election was duly given; that said election has been made and delivered by Bell County Elections Division; and that the City Council has duly canvassed said returns all in accordance with the Texas Election Code.

Section 3. That the City Council officially finds and determines that resident voters of the City of Nolanville, Texas were allowed to vote at said election, and the following votes were cast at said election, and that the canvass of the votes cast in the said election and returns thereof, which is attached hereto as *Exhibit A*, were made in accordance to the Texas Election Code.

Section 4. Pursuant to the applicable provisions of the Texas Local Government Code, Texas Election Code, and the City of Nolanville, Texas the City Council officially finds and determines and declares the results of said elections reflect as follows:


