



**ORDINANCE NO. E 21-08 #1**

**CITY OF NOLANVILLE, TEXAS**

**AN ORDINANCE CALLING AND ORDERING A GENERAL ELECTION FOR THREE (3) COUNCILMEMBERS FOR TWO (2) YEAR TERMS: PRESCRIBING THE QUALIFICATIONS FOR CANDIDATES; PROVIDING FOR THE FILING OF WRITTEN APPLICATION TO HAVE THEIR NAMES PRINTED ON THE OFFICIAL BALLOT; FIXING THE TIME WITHIN WHICH SUCH APPLICATION MAY BE FILED; SPECIFYING THAT THE PROVISIONS OF THE GENERAL ELECTION LAWS SHALL CONTROL ALL QUESTIONS PERTAINING TO SUCH ELECTION; PRESCRIBING THE CONTENTS OF THE OFFICIAL BALLOT; ADOPTING A BILINGUAL ELECTION ORDER, AND PROVIDING FOR POSTING AND PUBLICATION OF NOTICE OF SAID ELECTION:**

**WHEREAS,** the terms for three (3) City Councilmembers are scheduled to expire at the next uniform election date, that being November 2, 2021; and

**WHEREAS,** the next regular municipal election day for the City of Nolanville, Texas is the uniform election day occurring on November 2, 2021.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOLANVILLE, TEXAS THAT:**

**SECTION I.**

A general election is hereby ordered to be held on November 2, 2021, for the purpose of electing three (3) At-Large Councilmembers for the City of Nolanville, Texas. An Election Order, in English and Spanish, attached hereto as Exhibit "A" and Anexo "A," are incorporated by reference herein, and are hereby adopted and ordered.

**SECTION II.**

Any person shall qualify to run for Councilmember who meets the qualifications stated at Section 3.03 of the Nolanville City Charter. A candidate's application for a place on a ballot for the general election must be filed by **5:00 p.m. on August 16, 2021**. The earliest date for a candidate to file said applications for place on the ballot will be **July 17, 2021**.

**SECTION III.**

Early voting locations will be held at the Bell County Courthouse Annex, 550 East 2<sup>nd</sup> Avenue, Belton; Bell County Annex, 205 East Central Avenue, Temple; Parks & Recreation Center, 307 Miller's Crossing, Harker Heights; Bell County Annex, 304 Priest Drive, Killeen; Killeen Community Center, 2201 E. Veterans Memorial Boulevard, Killeen; and Salado Church of Christ,

217 North Stagecoach, Salado; between the hours of 8:00 a.m. and 5:00 p.m. October 18, 2021 through October 22, 2021; 7:00 a.m. through 7:00 p.m. Saturday, October 23 2021; 12:00 p.m. through 5:00 p.m. Sunday, October 24, 2021; 7:00 a.m. through 7:00 p.m. October 25, 2021 through October 29, 2021.

#### **SECTION IV.**

The City election precincts and polling places designated for holding the election are identified in the attached Order of General Election, attached hereto as Exhibit "A" and Anexo "A," and such attachment is incorporated herein by reference for all purposes. The polling places shall be kept open from 7:00 a.m. to 7:00 p.m.

#### **SECTION V.**

Notice of said election shall be posted by the City Secretary and shall be distributed by: 1) publishing notice of the elections, in English and Spanish, at least once, not earlier than the 30<sup>th</sup> day nor later than the 10<sup>th</sup> day before election day, in a newspaper of general circulation in the said City; and 2) not later than the 21<sup>st</sup> day before election day, by posting notice of the elections, English and Spanish on the City's bulletin board and City's Website used for posting notices of the meetings of the Nolanville City Council.

#### **SECTION VI.**

The City Secretary is authorized to execute a contract for election services between Bell County and the City of Nolanville for services to be provided for early voting and on November 2, 2021, and as specified in said contract.

#### **SECTION VII.**

The way and manner holding said elections, the notice to be given therefore, the polling places, the personnel and the officers who are to hold same, and all details connected with the holding of the elections shall comply with all applicable law and be provided for and arranged by Bell County Elections Department, Belton, Texas. Any omission or irregularity in the notice of elections or in the publication or posting of the notice of elections, or in the signing of same, shall not in any way affect or invalidate such elections.

#### **SECTION VIII.**


It is hereby officially found and determined that the meeting at which this ordinance was adopted and said election was called was open to the public and public notice of the time, place, and purpose of said meeting was given, all as required by Chapter 551 of the Texas Government Code.

**SECTION IX.**

This ordinance and the bilingual (Spanish) Election Order attached hereto as Exhibit "A" shall take effect and be in full force and effect from and after the date of its passage, and it is so ordained.




