

#### **RESOLUTION NO. E 22-11**

### CITY OF NOLANVILLE, TEXAS

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NOLANVILLE, TEXAS, CANVASSING THE ELECTION HELD ON NOVEMBER 8, 2022, BY CERTIFYING THE GENERAL ELECTION RESULTS; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

- WHEREAS, pursuant to Ordinance No. E 22-08, adopted on August 4, 2022, a General Election was duly held on the 8<sup>th</sup> day of November, 2022, for the consideration of electing three (3) councilmembers for City of Nolanville, Texas; and
- WHEREAS, said election was held with the solemnities and formalities necessary to make it a valid election, all notices having been posted in the manner and for the length of time required by law; and
- **WHEREAS**, only duly qualified resident voters of the City of Nolanville, Texas, voted at the General Election was called and held on November 8, 2022; and
- WHEREAS, section 67.003 of the Texas Election Code, as amended, generally provides that each local canvassing authority shall convene not later than the eleventh (11<sup>th</sup>) day after the election date for the purpose of canvassing the election results; and
- WHEREAS, section 67.004(a) of the Texas Election Code, as amended, establishes the quorum level required to canvass election results; and
- **WHEREAS**, a quorum of the City Council met on Wednesday, November 17, 2022, and duly canvassed the election returns of the above-mentioned election and finds that the tabulation of the results of the election is correct, hereby attached as *Exhibit A*.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NOLANVILLE, TEXAS, THAT:

- <u>Section 1.</u> The findings set forth above are incorporated into the body of this Resolution as if fully set forth herein.
- Section 2. That the City Council officially finds and determines a General Election was duly ordered to be held in the City of Nolanville, Texas on the 8<sup>th</sup> day of November 2022 for the purpose of electing a Mayor and (2) Councilmembers for the City of Nolanville, Texas; that proper notice Resolution NO. ### **ORDINANCE NO. R 2022-07**

AN ORDINANCE PROHIBITING DRILLING AND MINING OR THE REOPENING OF ANY ABANDONED WELL OR MINE IN ANY PUBLIC PARK LOCATED WITHIN THE CITY LIMITS OF NOLANVILLE, TEXAS.

### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOLANVILLE THAT:

- 1. All forms of drilling and mining are permanently prohibited in any public park located within the City limits of Nolanville, Texas;
- 2. No previously drilled and abandoned well or mine may be reopened in any public park located within the City limits of Nolanville, Texas;
- 3. The City Council hereby finds and declares that the adoption, passage, and implementation of this ordinance shall be effective as of first reading.
