I hereby acknowledge that I have read this application and state the above is correct and agree to comply with the City of Nolanville Ordinances and State Laws regulating zoning and building construction. I also certify I am the property owner or am authorized to act as the property owner’s agent in obtaining this permit. False or incorrect information will be grounds for permit to be revoked or denied. If work is commenced prior to a permit being issued, the permit fees will be doubled.

**No work is to be started before the permit application has been approved, paid in full and issued.**

**NOTICE: A CERTIFICATE OF OCCUPANCY MUST BE ISSUED BEFORE ANY BUILDING IS OCCUPIED.**

Any person who violates any of the provisions of this article, article 5.02 or the codes hereby adopted, or who fails to comply therewith, or with any of the requirements thereof, within the city limits shall upon conviction be guilty of an offense and shall be liable for a fine not to exceed \$500.00, provided that anyone convicted for a violation of any regulation hereby adopted governing fire safety or public health and sanitation, including dumping of refuse, shall be liable for a fine not to exceed \$2,000.00. Each day the violation exists shall constitute a separate offense. Any such penalties shall be in addition to all other remedies provided herein or otherwise available at law or in equity.
