#### Minutes for THURSDAY, MAY 16, 2013

To consider and to act on the following Agenda:

Call to Order and Announce a Quorum is Present. Mayor Rosenthal called the meeting to order at 6:00 p.m. and announced that a quorum was present. Mayor Rosenthal, Dennis Biggs, Sherri Morales and Duane Hampton were present; Sherese Karlsson arrived at 6:04 pm. Lacie Hicks was absent.

A. Nolanville City Council will hold a public hearing for the purpose of receiving public comments on zoning regulations for the 15.045-acre tract known at Phase IV of Bella Charca that was recently annexed into the City on March 26, 2013.

## 8. NEW BUSINESS AND ACTION ITEMS:

- A. Receive preliminary report from the Planning and Zoning Commission concerning the zoning of the 15.045-acre tract that is known as Phase IV of Bella Charca that was recently voluntarily annexed into the City on March 26, 2013 Candace Landis with the Planning and Zoning Commission gave the preliminary report to the City Council stating that the Planning and Zoning Commission met on May 6, 2013 and that they would recommend that the 15.045-acre tract that is known as Phase IV of Bella Charca that was recently voluntarily annexed into the City on March 26, 2013 be zoned as R-1S
- **B.** Discussion and possible action on the zoning of the 15.045 acre tract that is known as Phase IV of Bella Charca that was recently voluntarily annexed into the City on March 26, 2013. Motion was made by Councilmember Morales to accept the recommendation from the Planning and Zoning that the 15.045-acre tract that is known as Phase IV of Bella Charca that was recently voluntarily annexed into the City on March 26, 2013 be zoned as R-1S. Motion was seconded by Councilmember Hampton. Motion carried 4-0.
- C. Discussion and possible action to Award Construction Contract on the 2012 Texas Community Development Block Grant on Behalf of Bell County WCID #3 to Bruce Flanigan Construction, Inc. for \$295,433.00. Trae Sutton with KPA Engineering came before the council stating that awarding of the Construction Contract was the next step for the Plaza area and that this project was to do another 3 streets. He mentioned that the service lines for these residents would be moved to the streets for easier access for maintenance and repairs. Mr. Sutton also mentioned that this was Phase II of the Grant Project and that there were still four streets that were to be done to complete the project. The question was asked about how long the project would take to be

completed and Mr. Sutton stated that the timeframe on the completion is based on the awarding of the grants.

Motion was made by Councilmember Biggs to Award Construction Contract on the 2012 Texas Community Development Block Grant on Behalf of Bell County WCID #3 to Bruce Flanigan Construction, Inc. for \$295,433.00.

Motion was seconded by Councilmember Morales. Motion carried 4-0.

**D.** Discussion and possible action to direct City Manager to move forward with working on creating a planned development district for a possible Zoning Ordinance Amendment.

City Manager discussed the Zoning Ordinance Amendment stating that he, the Mayor and some land developers had a meeting and discussed a large development for Nolanville, in which would probably require a planned development district. He said he was asked to address the council to see if it might be something, in which they would be interested in looking at and to create a planned development zoning category. To regulate to do this, the order of process would be for the council stating that this is a course of action they are interested at looking into, would need to work with the attorneys and the land planner to come up with some different ideas, then go through planning and zoning, set and hold public hearings, work to amend the ordinance, then bring it back to the council to see if it is something that the council would want to approve and advance with. The City Manager requested the council to look at and read the handouts and the information that they were given to get a better resource of understanding. This is only a preliminary phase to give the City Manager approval to move forward. Motion was made by Councilmember Morales to direct City Manager to move forward with working on creating a planned development district for a possible Zoning Ordinance Amendment.
