7. NEW BUSINESS AND ACTION ITEMS:

A. Discussion and possible action for Council approval of the Zoning Ordinance No. 6051-12-SECOND READING

AN ORDINANCE REPEALING ORDINANCE NO. 6051-08 IN ITS ENTIRETY, CHANGING AND UPDATING ALL ARTICLES THEREIN, ESTABLISHING COMPREHENSIVE ZONING REGULATIONS FOR THE CITY OF NOLANVILLE, TEXAS, AND PROVIDING FOR THE USES AND REGULATIONS, ADMINISTRATION, ENFORCEMENT, AND AMENDMENT THEREOF, IN ACCORDANCE WITH THE LAWS OF THE STATE OF TEXAS, AND FOR THE REPEAL OF ALL PRIOR ZONING ORDINANCES AND ALL ORDINANCES IN CONFLICT HEREWITH: There were several comments made for the Zoning Ordinance, those being;

Gary Freytag-7353 W Adams Ave, Temple,-Bare Land Development spoke to the council about the ordinance being changed from 100% to 80% use of the hardy board versus masonry but is asking that the council reconsider the 80% usage. Stating that the hardy board is just as durable and weather sustainable but for the lower cost than the masonry.

Alex Ulrich-1315 Grand, Cleburne,-James Hardy Building Products, stating that there were 2 of their companies Texas based and then passed around samples of the company product of the hardy board and let the council know that there were references to the product warranty. He then asked the council if there were any questions and there were none.

Meg Belmontes-406 Heidrich, Houston,-Texas Masonry Council and wanted to let the council know that she felt the ordinance was very well done, stated that the definition for the term masonry that is in the ordinance is right in line with the International Building Code and the International Residence Code. She explained what the masonry units were defined as.

Nita Sims-207 N Main, Nolanville,-Planning and Zoning, stated that she was wanting to speak on the Zoning Ordinance and apologized for not making the last meeting and stated that there seemed to be some confusion on the recommendations that were made by the Planning and Zoning Commission for the side entry garages. Ms. Sims says this only applies to the larger lots and not to the smaller homes and lots. These are minimum guidelines and that these recommendations were worked on extensively by the Planning and Zoning. These recommendations are to make the residents look better and

more acceptable to the public as they drive by these homes.

Councilmember Hicks stated that the side entry recommendations were in letter form and had not been presented to the council the way that Ms. Sims had just demonstrated. Councilmember Hicks told Ms. Sims that the R-1E District had been diminished and that the R-1 and R-1S was what would be in effect. The recommendations for these districts did not have the side entry garages but that with the front entry would have a 25' setback and that this was done due to the way the lots are laid out.

Leila Siqueiros-1104 Fossil Cave, Round Rock,-Community Planner with Texas Masonry Council, states that with the masonry, there is less maintenance and it is more susceptible to the high winds and storm damage that can play a role in the Central Texas Area and ask that the council consider the masonry product for the homes. Due to the fact that it last much longer, more durable, less maintenance, withstands the weather and for the safety issues of the product.

Mayor Stewart spoke to the council on his behalf about the projected population growth and states that in Nolanville the population is also growing. He told the council that he makes over \$100,000/year and that he lives in a 2400 sq. ft. manufactured home and has lived in it for 14 years. His home does not have brick on the outside and he has to do minimal maintenance on his home. Mayor Stewart spoke on the affordability of the homes that is needed in Nolanville and states that if the restrictions are set too high or are too restricted then homes either won't be built or sold due to the fact that there are many that can't or won't be able to afford the homes.

Councilmember Hicks mentioned to the council and the citizens that she feels that with the changes that had been made to the zoning ordinance on the homes and the division areas that the ordinance is satisfactory and has been very well written and does not recommend any further changes to the way the draft reads now.

Tallbear Montez, spoke to the council about a concern with the senior citizens and the help that they may need help in making home repairs, asking if there were any programs to help the senior citizens out. Sally Burchett mentioned that there were some grants available and that the Meals on Wheels were sometimes willing to help.

Councilmember Hicks ask the Council to look at SECTION 551.9 of the new draft change the wording in (1) from SPACE to BUILDING, to read, performed in an enclosed building.
