Call to Order and Announce a Quorum is Present.

- 1. CALL TO ORDER Mayor Rosenthal called the meeting to order at 6:03 p.m.
- 2. <u>ROLL CALL</u> Council members Dennis Biggs, Sherri Morales, and Duane Hampton were present. Council members Sherese Karlsson and Lacie Hicks were absent.
