Emma McCullough, former Mayor and resident wanted to request the City Council to look into the whereabouts of the Fire Truck. Mrs. McCullough also wanted to let everyone know how excited she is to know the City will be getting a splash pad for the City of Nolanville.

Ed Mitchell, expressed his concerns about the City culvert and wants something done to ensure this type of accident doesn't happen again.

Patricia Warden, Nolanville's 1st United Methodist Church introduced herself as the new pastor. She is excited to participate with the Jamboree and future City Events.

Aurelia Ridley wanted to reassure citizens that although the City is restoring the Community Center, there are keeping the history with pictures and a plaque with names will be placed in the center in memoriam.

Colleen Smith, President of Nolanville's Economic Development Corporation provided summary of request to the City Council. Ms. Smith explained the Resource Room to be multipurpose room will be utilized for city, community and board uses.
