REGULAR MEETING MINUTES THURSDAY, NOVEMBER 2, 2017 at 6:00 PM.

Mayor Christina Rosenthal called the meeting to order at 6:00 p.m. and announced that a quorum was present. Mayor Pro-tem Butch Reis and Council members Joan Hinshaw, George French III, David Williams and James Bilberry were present.

Councilmember Joan Hinshaw made a motion to approve Park Facilities Ordinance No. R 17-11; motion second by Councilmember James Bilberry. All voted in favor. Motion carried 5-0.
