

REGULAR MEETING MINUTES December 6, 2018

1. CALL TO ORDER, INVOCATION AND PLEDGES TO FLAGS

Mayor Andy Williams called the meeting to order at 6:00 pm. A quorum was present. Mayor Pro-tem Joan Hinshaw and Councilmembers Butch Reis, George French III, David Williams and James Bilberry were all present.

- 4) City does not provide street maintenance only gravel placed on roads as repair

- 5) The comparison of the before and after of Old Nolanville Road that is part of the City doesn't look any better.
- 6) Residents of Tumbleweed want to remain separate and not part of any city.
- 7) A letter was received in the mail by Councilmember James Bilberry; he read the letter aloud. Paul Thomas, writers of the letter was present for the hearing.
