### 4. NEW BUSINESS AND ACTION ITEM:

A. Discussion and possible action to approve the use of \$255,000 from the General fund balance. This amount includes the previous purchase of the real property located at 101 North 5<sup>th</sup> Street for the amount of \$155,000 and additional funds to be utilized for furniture and renovations of this property for the amount of \$100,000.

Discussion commenced. City Council members expressed their concern with the condition of the roof of this property and that replacement of the roof is overdue.

Motion was made by Councilmember David Escobar to approve using the total of \$315,000 from the General Balance Fund and to amend the current budget to increase the capital outlay. This amount will include approval for placing \$155,000 under account 5101-4000 for the real property purchase of 101 North 5th Street and \$160,000 under account 5101-4100 for building renovations and furniture; motion was seconded by Mayor Pro-tem Dave Brackmann. All voted in favor. Motion carried 4-0.

Councilmembers specifically requested that \$60,000 be added to the originally listed amount to be utilized for roof replacement.
