

PUBLIC NOTICE TO BIDDERS ADVERTISING THE PROJECT

Sealed bids addressed to the Honorable Mayor and City Council will be received at the Nolanville City Hall; 101 N. 5th Street; Nolanville, Texas 76559 until **10:00 A.M. on Thursday, October 12, 2023** for the construction of the Nolanville Shared Use Path Improvements – Phase II in the City of Nolanville, Texas. The bids shall be labeled:

Bids must be submitted on the Bid Form provided and must be accompanied by a cashier's check, certified check or acceptable bidder's bond payable without recourse to the City of Nolanville, Texas in an amount not less than five (5) percent of the bid submitted as a guarantee that the bidder will enter into a contract and execute a Performance Bond and a Payment Bond within ten (10) days after the notification of the award of the contract.

The bids will be publicly opened and read aloud in the Conference Room in City Hall at 10:00 A.M. on Thursday, October 12, 2023. The City Council will officially review the bids at their next scheduled meeting and award the contract as soon thereafter as practicable after the City of Nolanville receives authorization for contract award from the Texas Department of Transportation (TxDOT).

The City of Nolanville reserves the right to accept or reject any and all bids, as the best interest of the City may require, and to waive any informality in bids received.

Each Bidder for this project is required to be listed on the Texas Department of Transportation Approved Contractor Roster.

This project includes, but is not limited to concrete shared use path, concrete culvert extensions, street widening, concrete curb installation, street rehabilitation and HMAC overlay, striping, SWPPP installations, prefabricated bridge structure installation, temporary traffic control, etc.
